- Old Business Dr. Jonathan Stout reviewed minutes for the January 11-12, 2018
 Advisory Board meeting that was conducted in Albuquerque, NM. Norman
 Shawanokasic noted his last name was misspelled in two different areas of the minutes.
 The January 11-12, 2018 minutes were accepted by all Board members. Norman
 Shawanokasic provided the motion to accept the January minutes. Ronald Worst second the motion. All approved the January minutes Norman Shawanokasic, Ronald Worst, Dr. Jonathan Stout and Adrienne Benally.
- Letter to the Secretary follow-up. There was no verification provided by the Secretary of the Interior that the document was received and reviewed.

New Business –

- o Jennifer Davis, DFO -
 - Needs to review travel vouchering procedures with the current Advisory Board members. This will be done during the orientation.
 - Conveyed to the Board members that the Charter will be renewed and will be sent through the DOI's DTS correspondence process for review.
- Donald Griffin, Division of Performance and Accountability (DPA), Supervisory
 Education Specialist for Special Education. (In person)
 - Would like to involve the stakeholders (BIE Advisory Board) to solicit information and seek input from the Board regarding the APR Data to EdFacts prior to submission of the data.
 - Will be providing new reports about special education topics.
- o Norman Shawanokasic, Board member discussed the issue of Board membership.
 - Two FRN's were issued and closed 1/29/18 and 7/16/18. There were
 9 individuals who applied for a Board position.
 - All potential candidate applications will be reviewed August 1-2,
 2018. No applications have been vetted at this time.
 - The Board membership has dwindled down to 7 members, with 2 board members terms expiring 9/10/18. We need to increase membership to the expected number of 15 board members.
 - The DFO submitted a third Call for Nominations 7/19/18. The closing date is set for 11/16/18.
 - Is alternate membership for appointed Board Members allowed?
 Mentioned as a possibility.
 - The Board has requested the DFO to place a request for the DOI Secretary to appoint a Chairperson. The Board agreed to recommend Norman Shawanokasic, current Board member to the DOI Secretary.

Dr. Jonathan Stout - took the lead to run the Advisory Board meeting

- The orientation overview was very focused compared to the process provided by a commercial contractor.
- The DFO identified a need to meet more than twice per year due to several reasons: there will soon be 10 more new Board members; the Board had two meetings each year for 2016 and 2017 which did not provide adequate interactions and opportunities to accomplish tasks. The first meeting is dedicated to establishing and planning priorities and work plans, the second meeting is reserved for working on the annual report.
- Norman Shawanokasic made a motion to amend the agenda. Dr. Harvey Rude seconded the motion to have Donald Griffin to report to the Board about special education topics of interest for the Board.

Donald Griffin, Supervisory Education Specialist, BIE/DPA/SPED – reporting

- The BIE's Special Education Program (BIE's/SPED) received the Level of Determination from the U.S. Department of Education, Office of Special Education Programs (OSEP).
 The BIE/SPED continues to "Need intervention." This Level of Determination has remained unchanted for the past seven consecutive years
 - Matt Sneer and Josiah Willey DOE employees provided the report.
 - BIE/SPED is short staffed DOE understands the BIE's complexities

- o How do we get BIE/SPED to meet the statutory requirements? There are various complex issues involved. For example, the application for the Part B grant was due 5/18/2018. The BIE submitted the Part B application to the DOI on time, however the document did not get to OSEP until three weeks after the due date. Don Griffin personally hand carried the application. The DOI Data Tracking System (DTS) slows the process down. Signatures are needed and processed which slows down the communication. As a result, the BIE still has not distributed Part B funds that were expected by 7/1/2018.
- Special conditions from the DOE have been added The BIE/SPED is required to use \$300,000 for secondary transition and post-school outcomes due to not meeting the target goal.
- O Don Griffin is trying to get everyone on board to see the importance of the BIE/SPED program. This requires a level of commitment beyond the Supervisory Education Specialists control.
- Annual Performance Report Reviewed Indicator 1 and 2, 4a. Graduation Rate (4 year cohort), Drop Rate (Students with Disabilities, grades 7-12) and Suspensions/Expulsions Rate (minimum N size). Described significant discrepancy which is three times the number of Students with Disabilities (SWD) as compared to the general education population within a school. There are 10 schools out of 118 BIE funded schools that have a significant discrepancy rating. We need to get the drugs and alcohol out of our schools. The significant discrepancy in the rate of suspensions and expulsions is directly related to drugs and alcohol usage in the BIE funded schools. This is a concern for both general and special education, and is related to student involvement with marijuana and alcohol. Students bringing weapons to school (two gun incidents) in our BIE schools, there are more incidents involving mainly knives being brought into schools by students in their backpacks.
- Assessment Participation and Performance All BIE funded schools data were reported for high stakes testing; 23 different state education agency assessments were collected and analyzed to get an Adequate Yearly Progress (AYP) for each school. Currently, participation and performance are reported. The Native American Student Information System (NASIS) reflects incomplete data due to schools not collecting and reported their test scores; students not taking the correct test, not taking the test at all, and taking the correct test without required student accommodations and modifications. A significant amount of SWD took the wrong assessment and those scores cannot be counted which lowered the response rate for this item. A single assessment for the BIE schools that can be distributed by BIE through a vendor is desirable. The BIE would collect and analyze the test data. This indicator has been our downfall out of compliance for the past 4 years. The target is 96% and current data reflects 71.96%
 - Don Griffin the BIE is going through Negotiated Rulemaking, proposal for a single assessment for BIE schools.

- Least Restrictive Environment (ages 6-21) Indicator 5 this area has not been a huge problem but the BIE is a bit below the goals. Inside the regular classroom 80% or more of the day the target is set at 74.50%, the BIE rated at 74%.35.
- Parent Survey (Indicator 8) BIE is one of the top 5 in the U.S. on the parent satisfaction indicator. The target is set at 48.00%, abd the BIE rated at 45.97%.
- Initial Evaluation (evaluations completed within 60 days) The target is set at 100%, and the BIE rated at 83.45%. The number of students getting initial evaluations has increased. Reasons for BIE's lack of compliance:
 - No data or documentation were entered in the database for a variety of reasons.
 Evaluator issues (e.g. illness, staff turnover, and contract issues), confusion regarding the 60 day timeline requirement, weather issues (e.g. impassable roads) and "no reason" or "other issues."
 - The BIE conducts a significant amount of technical assistance which does not benefit BIE schools in many instances since the benefitting staff leave and take the knowledge with them.
- Secondary Transition IEP Desk Audit (<u>sampling</u> 3 files per school minimum) Reviewed 307 IEP's. Significant need for improvement for this area. The target is set at 100%, and the BIE rated at 14.98%. The BIE is required to use \$300,000 to improve this indicator according to the DOE/OSEP.
 - BIE has been working intensely with Chemawa regarding this indicator that has resulted in improved performance.
- Post-School Outcomes (Indicator 14) 3 potential outcomes: A. enrolled in higher education; B. enrolled in higher education or competitively employed within one year of leaving high school (1+2); C. enrolled in higher education or in some other postsecondary education or training program or competitively employed in some other employment (1+2+3+4) Targets were met for A and B; but not met for Target C.
- Resolution and Mediation sessions (Indicator 15) Percent of hearing requests that
 resulted in resolution sessions that were resolved through resolution session settlement
 agreements. Less than 10 resolution sessions for the past 2 years which exempted BIE
 from setting target goals.
 - Jonathan Stout would like a list of services that are blocked due to contracting issues.
- State Systemic Improvement Plan (SSIP) Post-school outcomes was selected for this item. Target rate for SY 2014 = 71.50% (the BIE rate was 73.27%); SY 2015 = 73% (the BIE rate was 64.26%); SY 2016 = 74.50% (the BIE rate was %)
- Significant Needs for the BIE/SPED Program

- Quality staff at all levels
 - Direct services
 - Data quality
 - Timely, valid and accurate reporting of data
- Untrained paraprofessionals need to be trained.
- Education Resource Center (ERC's) SPED program knowledge to provide direct assistance to schools – this area needs improvement.
- Contracts for services also need to be improved.
- Understaffing at SEA (8/17 positions filled (4 are on hold) Dr. Rude any data on getting fully staffed? The Chinle and Crownpoint positions have been moved to Albuquerque (ABQ) and the certificate is being developed.
- Positives for the BIE/SPED Program:
 - SEA staff genuinely cares for SWD staff invests long hours in service to SWD.
 - The BIE utilized DOE funded Technical Assistance (TA) Centers staff to SEA to help the Part B SEA team;
 - Fiscal Accountability process, procedures, oversite
 - Data Submission (EDEN, APR) the BIE has submitted data on time for the past 3 consecutive years;
 - Monthly TA calls for BIE funded schools started spring 2018; calls are recorded and placed on BIE website; is there a counter on the website to see how many times the recorded TA was accessed online? We need to check on this.
- Part B application Norman Shawanokasic. wanted more information about this;
 - Don Griffin the DPA/SPED staff is reviewing the applications; and does not plan to distribute funds until all required documents are submitted to BIE as required.
 - The BIE submitted the application grant on May 10, 2018; need to meet the 60 day window open for public comments for the Part B application; DOE requested the application by May 15, 2018. Consequently, funds are not being released to BIE/SPED by 7/1/2018. DOE has not issued the grant award to the BIE/SPED, which means Bie/SPED can't distribute funds to the local education agencies in the BIE system.

Most school will open at the end of July including the Navajo schools. Dr. Stout asked, "Are the schools being notified?" Don Griffin states, "No." The schools potentially face consequences (i.e. not receiving SY 2018-19 special education funds when school starts) since the Part B application was not approved on time.

- BIE/SPED may possibly go through a Government Account Office (GAO) review regarding service issues and data reporting.
- Norman Shawanokasic thanked Don Griffin for the SPED report; glad to see positives and not all negative reporting about the BIE/SPED program. Was the BIE's

reorganization chart signed? Don Griffin stated, "I don't think it has been signed. Not sure. I will need to check on this."

• Dr. Jonathan Stout – The Advisory Board wrote a letter to Secretary Zinke for the 2017 Annual Report. The format for the 2018 Annual Report will include correspondence that references a chart. All Board Members will sign the letter.

Break - 11:00 a.m. to 11:15 a.m. MT

- O The Board plans to meet again this fall as a work group session to complete the 2018 Annual Report. The work group session will be 9/22/2018, Travel day for the Board Members will be Friday, 9/21/2018. The location will be in the large conference room #326 starting at 8:30 a.m. MT. There will be a working lunch; and work group session will end at 4:30 p.m. MT. The 2018 Annual Report will be finalized at the end of the work day.
- Dr. Harvey Rude would like to know the status of the re-organization. Dr. Hamley suggested the Board speak with Maureen Leskey to get an update.

Dr. Jeffrey Hamley – Associate Deputy Director for the Division of Performance and Accountability. DPA Updates

- Unable to make the Advisory Board meeting in-person due to prior commitments to ensure the 2018 BIE summer regional meetings ran smoothly.
 - To keep cost down the BIE suggested regional conferences; although this may be problemeatic due to the increased amount of work for DPA to be responsible for presenting at the meetings, arranging logistics, planning, coordinating and approving travel.
 - Feedback from schools summers training needs to be planned well in advance for next year and advertised early.
 - Attendance was low at two sites; Santa Fe and Phoenix sites were well attended.
- Negotiated Rulemaking the Federal Register Notice (FRN) will be published July of 2018. Three meetings are planned (orientation, virtual and in-person meeting); The provisions of the previous No Child Left Behind mandates imposed a greater agenda with a long list of activities to address – one of them was to use a central unified

accountability system or go with a State's accountability system. BIE/SPED expressed intent to change to a unified BIE accountability system for the next 10-15 years until Elemenatary and Secondary Education Act (ESEA) is re-authorized.

- Committee names published Dr. Hamley has directed the DFO to email a copy of the names of the members of the Negotiated Rule Making committee to the BIE Advisory Board.
- State Plan provisions fall under the Every Student Succeeds Act (ESSA). SWD are covered within the ESSA. A current draft is published on the BIE website. Based on feedback received at one feedback meeting, it is clear that the Tribes do not want a blank slate. The BIE presented a template for utilization by tribal education agencies. The tribes want written ideas on the template so they can discuss potential ideas on the template. BIE will form a second committee to update and place more options in the plan for stakeholder input. The goal is to have more robust stakeholder input. The state Plan and Negotiated Rule making are linked. BIE cannot finish the State Plan until the Negotiated Rule Making is completed. BIE will take that information and place it in the State Plan (SP). The BIE Director is committed to have a BIE State Plan. BIE will take the State Plan out for tribal consultation Spring 2019. Tribal consultation is for tribal leaders. What about non-tribal leaders? In addition to consultation, for community members, BIE will speak with parents, school staff members and will provide them feedback about the BIE's State Plan.
 - Dr. Harvey Rude any possibility to individualize the SP for the regionals of the BIE schools? Navajo Nation and Miccosukee has developed their own accountability system. We also have some other schools who are interested in TA to explore how they can develop their own accountability system.
 - SP is organized by programs Title 1a, etc. The SP requires to meet the requirements of ESSA for all schools who receive Title 1a, 21st century or McKinney Vento funds.
- Hiring personnel we have vacancies; the SPED program has the most. The litigation is still pending in the Dakotas. Until the legal issues are settled all positions in this area have to be placed on hold.
 - DPA when hiring the DPA now have been allowed to place the position (duty station) where the need is. This provides flexibility for DPA. Currently, for example Crownpoint has experienced difficulties in hiring 2 positions, so if BIE moves to Albuquerque there should be greater opportunity to fill the 2 positions.
 - BIE/SPED proposed to move the DPA staff in Washington, D.C. to ABQ, but the plan has not been approved as of this date. Greater levels of support is required for the ABQ operations.
 - The Associate Deputy Director (ADD) Bureau Operated Schools (BOS) position was recently filled. This was a SES transfer, not a hire. The SES Board did the transfer.
 - The Chief Academic Officer (CAO) will be filled as a competitive hire. A review panel will be formed. The BIE Director will make final decision. There are 179 applicants for the CAO.

- Don Griffin the position for recent applicants, a question was raised regarding whether certificates have been received. Dr. Hamley will schedule time with HR to review applicants.
- The U.S. Government Accountability Office (GAO) is interested in looking at special education programs in BIE funded schools. Investigation studies for Congress include the following areas of interest: timely IEPs, qualification of staff, services provided, and effectiveness of BIE monitoring.
- Budget working on this to place funds and redistribute funds to schools after the DPA completes Undelivered Orders (UDO's).
- LRP Contract a free service for all BIE funded schools is a valuable resources to school personnel. There is a need to develop more robust outreach to all BIE school staff including general education teachers and paraprofessionals to access the LRP SPED modules.
- Indefinite Delivery, Indefinite Quantity Contracts (IDIQ) has been developed.
 Tasks orders will be placed to assist with DPA work and potentially share scope of work with the Advisory Board.
- Annual DPA meeting July 30 through August 3, 2018 in Albuquerque, will have WestEd facilitators to help with annual planning, plan monitoring, and formation of teams to do the planning.
- New policy developed for monitoring will soon be issued.
- Questions
 - Jonathan Stout Data Tracking System (DTS) any way to change DTS, it slows down the correspondence going out of the DOI? Jackie Cheek – suggested using templates for faster approval.
 - Jonathan Stout Contracting Officers not getting paid right away and refusing to work on the various reservations; any way to speed up the process?
 - Tony Dearman, BIE Director "Contracting is a big issue, we have a new contracting officer.; Currently we have over 6,000 contracts coming out of Gallup office and the Southwest office in ABQ.; We have been able to partner with BIA to get the contracts processed. We need to continue to keep up our partnership to make sure the contracts are processed on time. BIE is looking to get a warranted Contract Officers to help speed up the process. We also need to educate other federal offices of the roles of the BIE staff. We are working forward to get this issue resolved in a timely manner."

Tony Dearman, BIE Director – BIE Updates

- Hiring process for teachers the hiring process needs to be faster and improved; Tony Dearman – "We are looking at the problems in HR to see how we can resolve them to improve our hiring."
 - BIE has been hiring additional NASIS staff to collect and analyze data.

- Bie needs to work with our students to think about becoming teachers within the BIE schools.
- Training needed for principals and teachers.
- GAO BIE/SPED staff are looking forward to the review. GAO will be implementing a
 detailed review of the BIE schools, and hopefully providing extra assistance for the
 purpose of making the BIE system better. BIE designated as a high risk federal agency. In
 June, 2017, BIE reported 9 out of 13 GAO recommendations have been completed. Now
 waiting for the DOI Secretary to approve the BIE Strategic Plan.
- BIE Summer Regional Training people are networking with each other, for the
 purpose of determining what is working and what is not, these type of trainings are
 needed; and participation has been good.; The BIE is getting a lot of positive feedback
 on the impact of these trainings. Don Griffin suggested regional SPED trainings. Schools
 are in need of training and are looking forward to them. The Advisory Board was
 encouraged to provide suggestions for improvements.
- Data behind on data and getting caught up for the past 5 years. As BIE/SPED builds capacity the need to ensure that data are up to date. Also want to stay up to date on BIE hiring process and information about personnel data.
 - SPED data reporting still needs improvement.
- Assessment BIE is dealing with 23 states; BIE asked DOE to assist with this complex issue. Expectations for the DOI secretary to approve a uniform assessment system for the BIE schools.
- Communications BIE is working on this issue. By the end of July 2018 the BIE will have a new BIE website to ensure communication to schools and tribal jurisdictions.
- Strategic Planning provided a brief overview of what has been completed. All comments on the SP will be posted on the BIE website. BIE is committed to being as transparent as possible. There has not been a consistent strategic direction for the BIE.
 - o Goal 1 Early Childhood collaboration will be improved with the tribes.
 - Goal 2 Behavior Health there is a high need in BIE schools; a Memorandum of Agreement with Indian Health Service specifies contacting all BIE schools to set up clinics within the schools. There is 1.8 million dollars available to the BIE and tribes to achieve this goal.
 - Goal 3 School improvement looking at how the process will result in increased learning and results for all students.
 - o Goal 4- Post Secondary we need to benefit post-school outcomes for SWD.

- Goal 5 Tribal Sovereignty to do this we need tribal leadership to plan and provide direction in collaboration with the BIE.
- Assessment Accountability the BIE is going through NRM to address this.
- Past Office of Inspector General (OIG) reports school violence, background checks for personnel – BIE fallen behind with 5 year investigation for federal employees; need to work with our tribes to make sure they are in compliance too with background checks. BIE is working with Internal Business Center to help with this.
- Residential Waivers residential staff are required to have 32 hours of college courses without resources to assist staff in meeting this requirement. This has made it difficult to hire residential staff, and BIE/SPED requires a plan from the school to ensure how the 32 hours will be obtained to facilitate hiring qualified staff.
- Senior leaders ADD to meet the advisory board at the next meeting
- Questions
 - Dr. Harvey Rude new commitments or initiative of professional development (PD) for school board members for various BIE funded schools? Will post school board resources on the BIE website and post upcoming school board training. Work with ERC staff to reach out for training activities.

Dr. Maureen Lesky, Program Manager for the BIE Office of Sovereignty – the Advisory Board asked for a brief overview of the BIE's Tribal Education Department (TED) grants.

- Ms. Lesky started her new position with the Office of Sovereignty 5 months ago, March of 2018.
- The Office of Sovereignty is part of the BIE reorganization.
 - Two positions are included with this office (Johnson O'malley and Early Childhood FACE Coordinator)
- 5 years ago a reform effort was implemented that included study groups and listening sessions which formed recommendations.
 - o Strengthen tribal capacity in area of tribal sovereignty supported by TED grants
 - o TED grants began in 2015 and were approved for 3 years for FY 15, 16 and 17.
 - o TEDs have receive additional funds for FY 18 which will address the FY2018-19
 - Last year 10 TED grants were awarded.

- FY 18-19 year BIE Director wants to open up to more tribes to apply. BIE working on revising solicitation and getting other required documents prepared before the grant can be opened up.
- o The TED grants must upload and post their information on grants.gov website.
- The application addresses 3 areas
 - 1. Building capacity of tribal education codes
 - 2. Strengthening tribal education control
 - 3. Tribal administrative support.
- o Tribes will provide a quarterly monthly report; and will meet with BIE monthly.
- There is page on the BIE website that shows a TED application. A new application will be posted when approved.
- A booklet is being developed will have an overview of goals and accomplishments of their TED grants
- The BIE is looking at an ending meeting such as NIEA so the TED grants can present about their grant.
- Working on possibility for TED grantees to meet with the Assistant Secretary of DOI regarding their TED grants.
- Dr. Jonathan Stout (Advisory Board members) provided information that the Council for Exceptional Children will have their 2019 Conference in Las Vegas, Nevada which will include a Native American strand for presentations. Hopefully the BIE can present at this conference.
