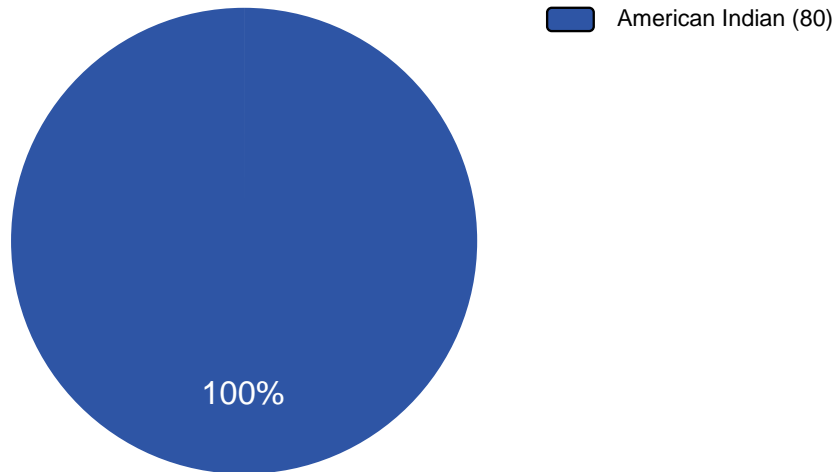

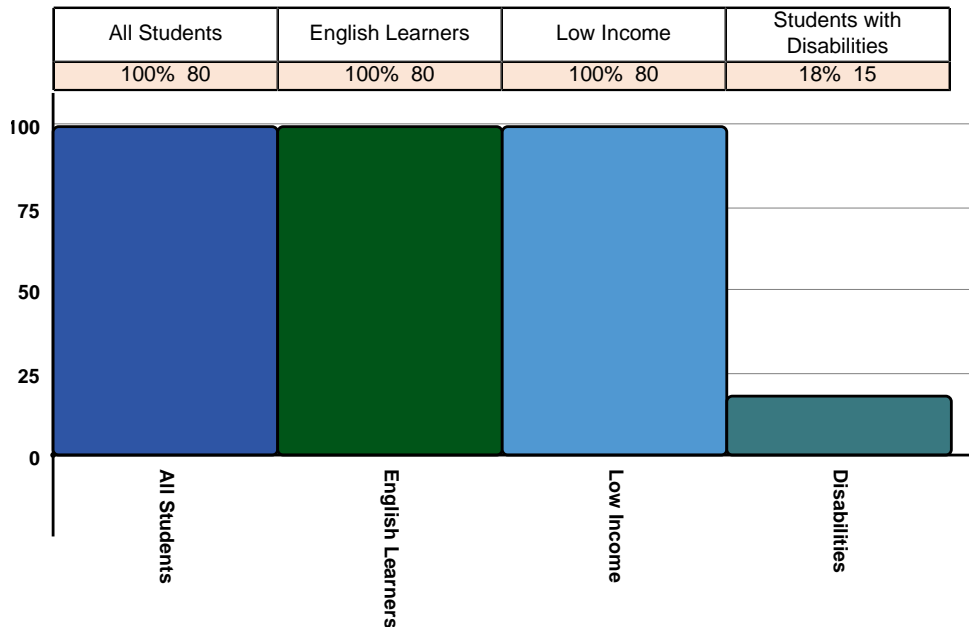

Enrollment by Race/Ethnicity



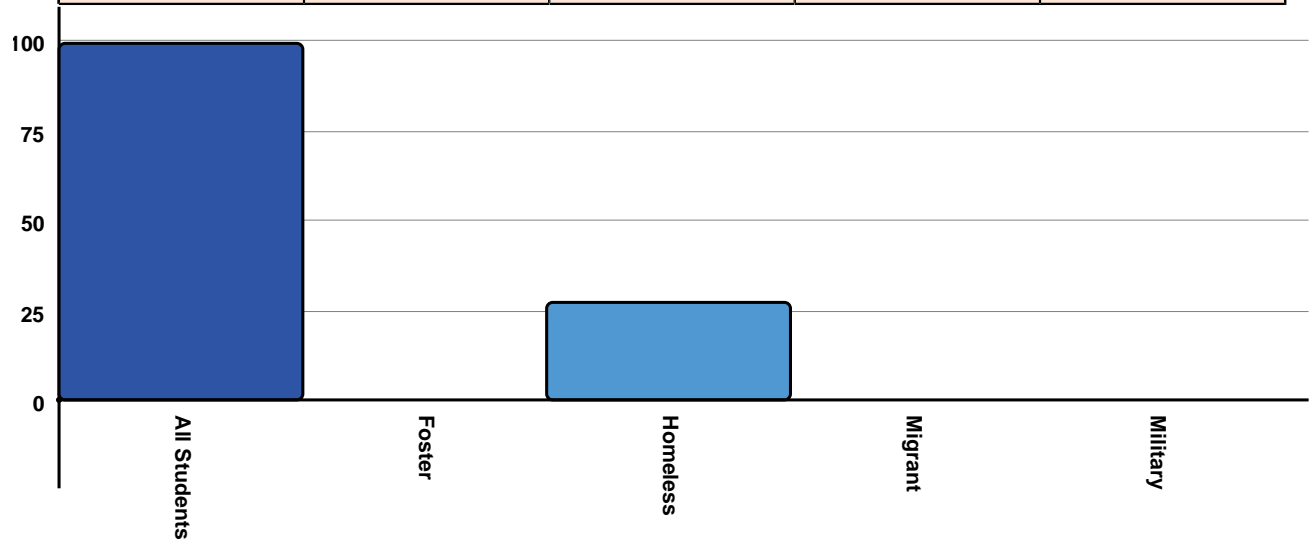

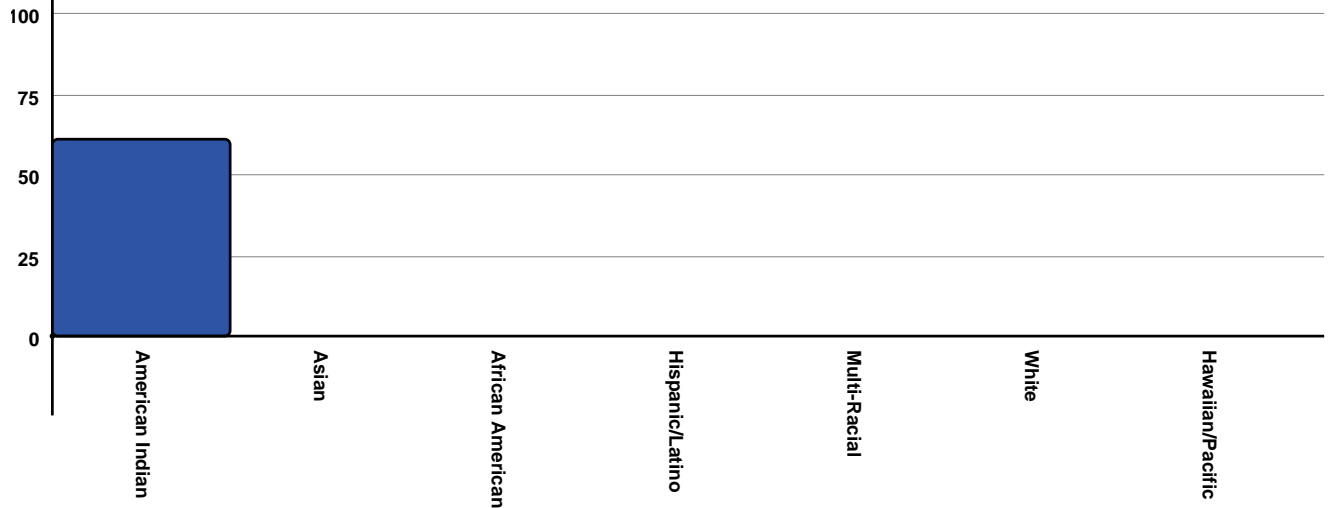

On Track Attendance by Race/Ethnicity

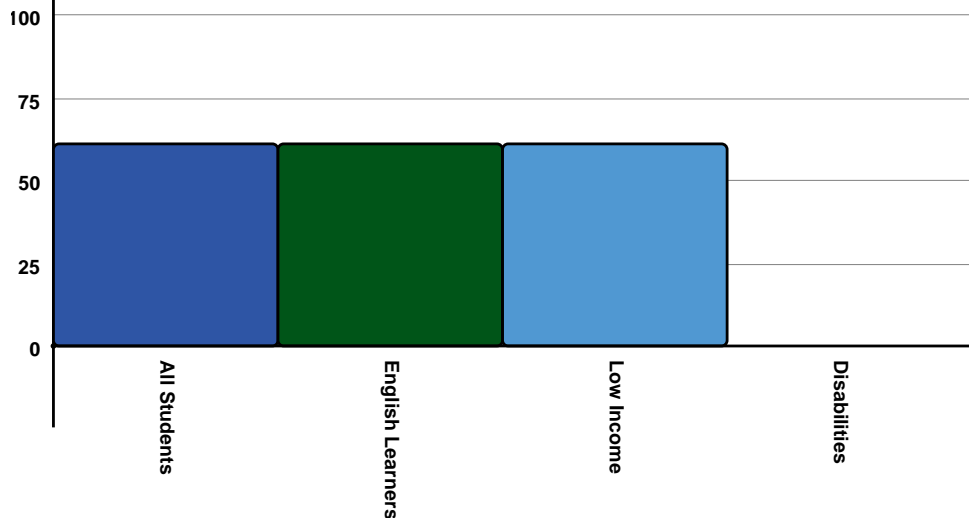

On Track Attendance by Other Characteristics

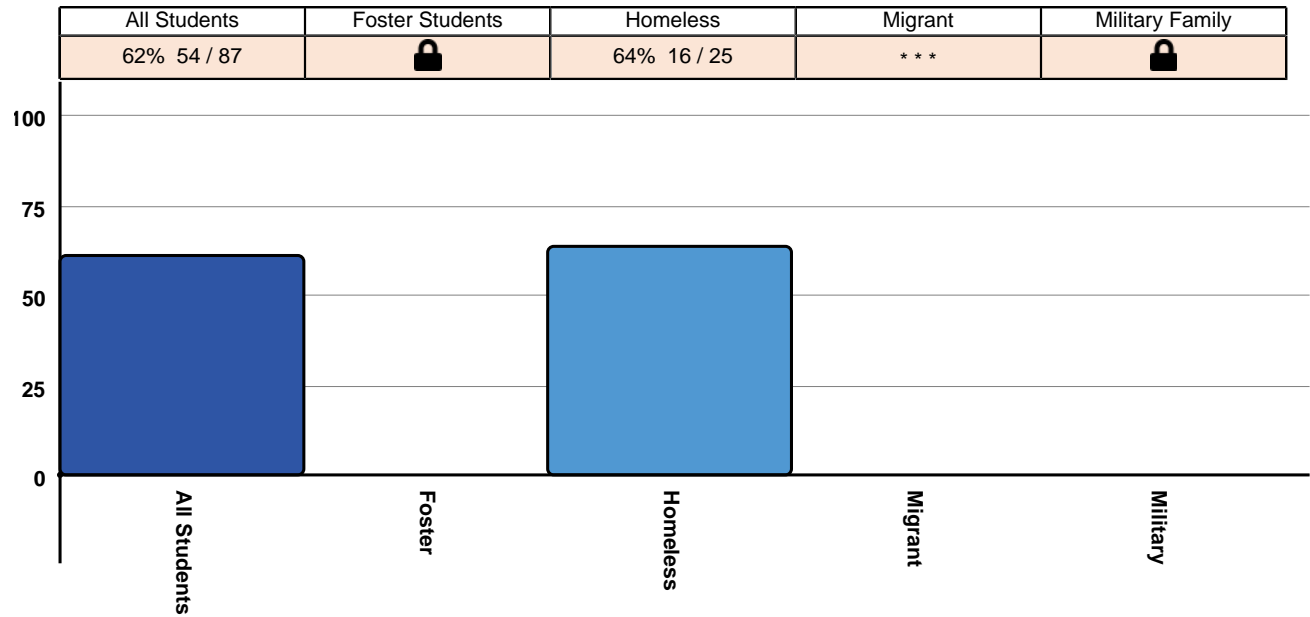
